Memorandum of Understanding For

Faculty & Student Exchange

This Memorandum of Understanding (MoU) is effective as on 15th July 2021

Faculty of Taywade College Koradi-Mahadula, Dist- Nagpur and Seth Kesarimal Porwal College, Kamptee, Dist-Nagpur to develop the faculty exchange program in education and research, have agreed to the following:

- 1. Based on the principles of mutual benefit and respect for each other's independence, the two institutions will foster:
 - a) Faculty Exchanges;
 - b) Joint Research Activities;
 - c) Exchanges of Academic Materials.
 - d) Students Exchanges
 - e) Skill Development
 - f) Entrepreneurship Development
 - g) Rural entrepreneurship

EXCHANGE OF TEACHERS & STUDENTS:

A. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative academic programme. Teachers and students of both the institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both the institutions.

B. Issues relating to travel, boarding, lodging, miscellaneous expenses shall be incorporated in this Para and shall vary according to the rules, regulations and policies of every institution.

The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.

C. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition(s) of this agreement.

D. The MoU shall remain in force for a period of 01 (One) year from the date of its signature and seal, and may be terminated by either side by giving a three months' notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.

E. The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

F. This MoU shall require the ratification of the competent academic/executive body of both the institutions.

 In order to carry out the above activities, a detailed plan may be agreed to upon consultation between the two institutions.

- It is implicit that every activity undertaken under this agreement is approved by the appropriate officials at each institution and must fall within each institution's academic and fiscal constraints.
- This agreement shall be effective on and after the date of its signing by the authorized representatives of the two institutions, and shall remain in force until either party wishes to terminate. In order to terminate, a three months written notice must be issued.








Program Flyer of Webinar on Career Opportunities in the Clinical Research Industry




Screenshot of Webinar on Career Opportunities in the Clinical Research Industry

Sect 120(1A)

Infringement proceedings in respect of an innovation patent cannot be started unless the patent has been certified.

Sec 128 Application for relief from unjustified threats

- (1) Where a person, by means of circulars, advertisements or otherwise, threatens a person with infringement proceedings or other similar proceedings a person aggrieved may apply to a prescribed court, or to another court having jurisdiction to hear and determine the application, for:
 - (a) a declaration that the threats are unjustifiable; and
 - (b) an injunction against the continuance of the threats; and
 - (c) the recovery of any damages sustained by the applicant as a result of the threats.
- (2) Subsection (1) applies whether or not the person who made the threats is entitled to, or interested in, the patent or a patent application.

Sec 129A

Threats related to an innovation patent application or innovation patent and courts power to grant relief.

Certain threats of infringement proceedings are always unjustifiable.

- (1) If:
 - (a) a person:
 - (i) has applied for an innovation patent, but the application has not been determined; or
 - (ii) has an innovation patent that has not been certified; and
 - (b) the person, by means of circulars, advertisements or otherwise, threatens a person with infringement proceedings or other similar proceedings in respect of the patent applied for, or the patent, as the case may be; then, for the purposes of an application for relief under section 128 by the person threatened, the threats are unjustifiable.

Courts power to grant relief in respect of threats made by the applicant for an innovation patent or the patentee of an uncertified innovation patent

(2) If an application under section 128 for relief relates to threats made in respect of an innovation patent that has not been certified or an application for an innovation patent, the court may grant the application the relief applied for.

Courts power to grant relief in respect of threats made by the patentee of certified innovation patent

(3) If an application under section 128 for relief relates to threats made in respect of a certified innovation patent, the court may grant the applicant the relief applied for unless the respondent satisfies the court that the acts about which the threats were made infringed, or would infringe, a claim that is not shown by the applicant to be invalid.

- (1) Where a person, by means of circulars, advertisements or otherwise, threatens a person with infringement proceedings or other similar proceedings a person aggrieved may apply to a prescribed court, or to another court having jurisdiction to hear and determine the application, for:
 - (a) a declaration that the threats are unjustifiable; and
 - (b) an injunction against the continuance of the threats; and
 - (c) the recovery of any damages sustained by the applicant as a result of the threats.
- (2) Subsection (1) applies whether or not the person who made the threats is entitled to, or interested in, the patent or a patent application.

Sec 129A

Threats related to an innovation patent application or innovation patent and courts power to grant relief.

Certain threats of infringement proceedings are always unjustifiable.

- (1) If:
 - (a) a person:
 - (i) has applied for an innovation patent, but the application has not been determined; or
 - (ii) has an innovation patent that has not been certified; and
 - (b) the person, by means of circulars, advertisements or otherwise, threatens a person with infringement proceedings or other similar proceedings in respect of the patent applied for, or the patent, as the case may be; then, for the purposes of an application for relief under section 128 by the person threatened, the threats are unjustifiable.

Courts power to grant relief in respect of threats made by the applicant for an innovation patent or the patentee of an uncertified innovation patent

(2) If an application under section 128 for relief relates to threats made in respect of an innovation patent that has not been certified or an application for an innovation patent, the court may grant the application the relief applied for.

Courts power to grant relief in respect of threats made by the patentee of certified innovation patent

(3) If an application under section 128 for relief relates to threats made in respect of a certified innovation patent, the court may grant the applicant the relief applied for unless the respondent satisfies the court that the acts about which the threats were made infringed, or would infringe, a claim that is not shown by the applicant to be invalid.

Schedule 1 Dictionary

certified, in respect of an innovation patent other than in section 19, means a certificate of examination issued by the Commissioner under paragraph101E(e) in respect of the patent
